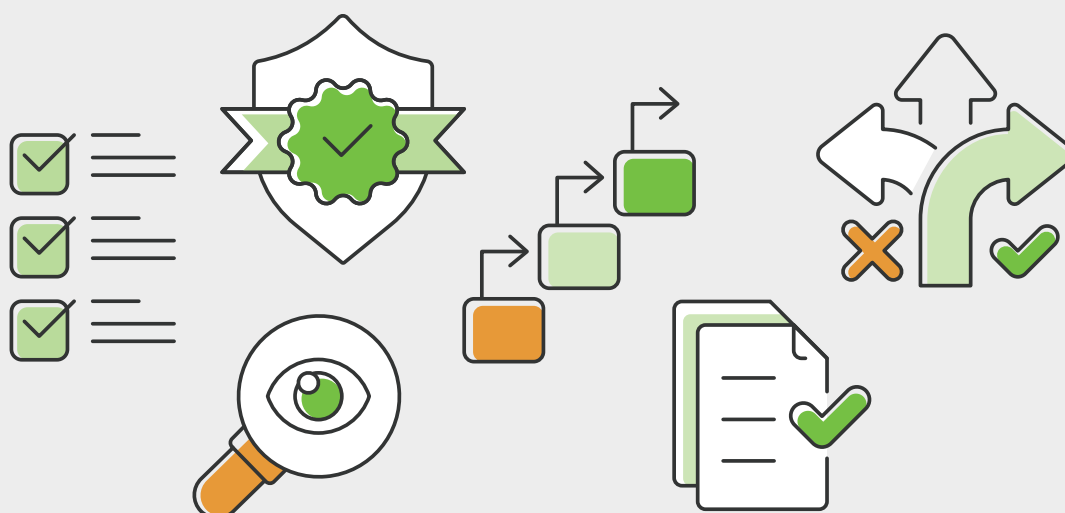

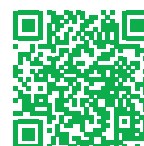

EU LEGISLATION RELEVANT TO THE TEXTILE INDUSTRY

To bring the ideas and intentions of the European Green Deal to life, the EU's body of sustainability legislation is expanding rapidly. The textile value chain is given high priority in this regard, which is reflected in many legislative and non-legislative measures and initiatives such as the EU Strategy for Sustainable and Circular Textiles.

These legislations create legally binding obligations on companies of the textile industry to address how they are managing their social and environmental impact, pushing for more corporate responsibility and for more sustainability by defining requirements for the design and the processing methods as well as for topics such as traceability, transparency, and waste management.

GOTS supports companies in meeting these legislations and even goes beyond compliance, setting rigorous requirements for fibres, ecological, human rights including social criteria and business conduct across the entire textile value chain.
